

RESOLUTION NO. 200499

APPROVING MAP OF FRIARS PROFESSIONAL PARK UNIT NO. 1  
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC  
THE PUBLIC STREET DEDICATED ON SAID MAP, AND ACCEPTING  
ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENTS  
GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by WILLIAM B. RICK, Registered Civil Engineer, and entitled,  
"FRIARS PROFESSIONAL PARK UNIT NO. 1 Being a subdivision of  
a portion of Pueblo Lot 1173 of the Pueblo Lands of San Diego,  
in the City of San Diego, County of San Diego, State of Cali-  
fornia, according to Map thereof made by James Pascoe in 1870,  
a copy of which said map was filed in the office of the County  
Recorder of San Diego County, November 14, 1921 and is known  
as Miscellaneous Map No. 36, together with a portion of Friars  
Road as vacated by Resolution No. 96290, dated December 27, 1949."  
is made in the manner and form prescribed by law and conforms  
to the surrounding surveys; that said map and the subdivision of  
land shown thereon is hereby approved and accepted; and said  
Council hereby accepts on behalf of the public, the public street,  
to wit: Mission Center Court for public purposes, and said street  
is hereby declared to be public street and dedicated to the  
public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts  
on behalf of The City of San Diego, a municipal corporation,  
the easements with the right of ingress and egress for the con-  
struction and maintenance of sewer and drainage facilities, as  
granted and shown on said map, and subject to the conditions  
as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
