APPROVING MAP OF PICKETT INDUSTRIAL CENTER SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENTS AND ABUTTERS' RIGHTS OF ACCESS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, Registered Civil Engineer, and entitled, "PICKETT INDUSTRIAL CENTER Being a subdivision of portions of Lots 1,2,3, and 4 of Pueblo Lot 275, in the City of San Diego, according to partition map made in an action entitled "Adolph Levi vs. Marcus I. Olmstead, et al.," in the Superior Court of The State of California, in and for the county of San Diego, as Case No. 1600.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, public streets, to wit: Hancock Street and Hicock Street, for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of THE CITY OF SAN DIEGO, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water, drainage facilities and public utilities as granted and shown on said map, and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of THE CITY OF SAN DIEGO, a municipal corporation, any and all abutters' rights of access in and to Houston Street, adjacent and contiguous to Lot 24, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with easements with the right of ingress and egress for the construction and maintenance of sewer, water, drainage facilities and public utilities as granted and shown on this map within this subdivision, are accepted on behalf of THE CITY OF SAN DIEGO, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
