BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Design Engineers and Associates, structural and civil engineers, for design and consultant services in connection with the addition of permanent bleacher seating at the easterly end of San Diego Stadium, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 732969.

BE IT FURTHER RESOLVED, that the expenditure of \$3,000 is hereby authorized out of Stadium Construction Fund 950, solely and exclusively for the purpose of providing funds for said project.
