BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Franklin T. Hamilton, Esq., be employed and appointed as special counsel for giving an opinion on any bonds that may be issued to pay for the improvements to be made in the HARBOR VIEW DRIVE UNDERGROUND UTILITY DISTRICT under the provisions of the Municipal Improvement Act of 1913, pursuant to the terms and conditions set forth in the letter dated July 17, 1970, on file in the office of the

City Clerk as Document No. 732978.

That in the event the proposed Improvement Act proceedings fail to materialize or are abandoned before an assessment has been levied and collected, the City shall not be liable for payment of any of the costs incurred in said employment.
