BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an easement for the purpose of a right of way for a public street (roadway) and incidents thereto, through, over, under, along and across the hereinafter described property be, and the land therein conveyed as Parcel 1 is hereby set aside and dedicated as and for a public street and the same is hereby named RANCHO PENASQUITOS BOULEVARD:

PARCEL 1 - Rancho Penasquitos Boulevard

A strip of land 102.00 feet wide lying within the Rancho Los Penasquitos, in the City of San Diego, County of San Diego, State of California, according to Map accompanying the Patent to said Rancho, recorded in the office of the County Recorder of said County in Book 2, Page 385 of Patents, the center line of said 102.00 foot strip being described as follows:

Beginning at a point in the Southeasterly line of said Rancho distant along said Rancho line North 45°34'07" East (Record North 45°00'00" East), 3983.07 feet from a 3 inch concrete monument with brass plates marked "R.E. 2718" set to mark corner No. 4 of said Rancho, said monument being at coordinate Y=280,825.42 feet and X=1,733,675.65 feet; thence North 04°26'24" West, 386.68 feet to an angle point in the Westerly boundary of the land described in Parcel 2A of Final Order of Condemnation, recorded June 26, 1967 as Document No. 92316 of Official Records; thence along the boundary of said Parcel 2A as follows:

North 55°29'56" East, 239.83 feet; thence North 35°02'10" East, 1072.69 feet; thence North 12°05'20" East, 528.44 feet; thence North 27°21'33" West, 359.82 feet; thence North 16°26'51" West, 201.44 feet to an


angle point; thence continuing along said boundary, North 80°04'50" East (Record North 80°04'56" East), 127.01 feet to the TRUE POINT OF BEGINNING; thence North 16°26'43" West, 1757.16 feet to a tangent 1700.00 foot radius curve, concave Southwesterly; thence Northwesterly along said curve through an angle of 41°33'17", a distance of 1232.95 feet to Point "X" of this description; thence tangent to said curve North 58°00'00" West, 1789.96 feet to the end of said easement.

Said 102.00 foot strip to terminate in the Northerly boundary of said Parcel 2A.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
