

RESOLUTION NO. 200543 **AUG 18 1970**

WHEREAS, there is at this time no specified area within the Mount Hope Cemetery for burial of San Diego area veterans; and

WHEREAS, the Veterans National Cemetery Association has requested that the City establish a "Veterans Memorial" section within the bounds of Mount Hope Cemetery as a tribute to area veterans; and

WHEREAS, the establishment of such a section would be at no added cost to the normal future development of Mount Hope Cemetery; and

WHEREAS, it would be most fitting and proper for the City of San Diego to set aside a specified area for such burials as a tribute to all area veterans who have served their country as members of the nation's armed forces; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized to set aside and designate a Veterans Memorial section within Mount Hope Cemetery.

BE IT FURTHER RESOLVED, that the following schedule of fees for lots and services for veterans' burials in the area so designated be, and the same is hereby approved:
