BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the offer of International Business Machines is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 500,000 ORIGINAL UTILITY BILLS at a cost of \$10.71 per thousand, 60,000 FIRST OVERDUE BILLS at \$10.59 per thousand, and 30,000 SECOND OVERDUE BILLS at \$10.59 per thousand, plus a set-up charge of \$256.24 for a total cost of \$6,564.34; terms net 30 days, plus sales tax.
