APPROVING MAP OF RESUBDIVISION OF BASIC SUBDIVISION
AND ACCEPTING ON BEHALF OF THE PUBLIC THE PORTION
OF PUBLIC STREET DEDICATED ON SAID MAP WITHIN THIS
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by RAYMOND F. HALL, JR., Registered Civil Engineer, and entitled, "RESUBDIVISION OF BASIC SUBDIVISION Being a subdivision of Lot 1 of Basic Subdivision in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5822 filed in the office of the County Recorder of San Diego County, January 20, 1967 and all of Lot 95 and portions of Lots 94, 104, 105 and 106 in Boulevard Gardens, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1505 filed in the office of the County Recorder of San Diego County, December 11, 1912.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the portion of public street, to wit: portion of Tecolote Road for public purposes, and said portion of street is hereby declared to be portion of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
