

A RESOLUTION ESTABLISHING FEES FOR LOTS
AND SERVICES AT MOUNT HOPE CEMETERY

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the following schedule of fees for lots and
services at Mount Hope Cemetery enumerated herein, as
recommended by the City Manager, pursuant to the San Diego
Municipal Code, be and the same is hereby approved:
