BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the offer of HAVENS INTERNATIONAL is hereby accepted and the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a contract for the purchase of ONE 20,000 GALLON PER DAY REVERSE OSMOSIS PROCESSOR for a total cost of \$76,000.00, plus tax.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$83,000.00 within the Sewer Revenue Fund (506) from the Unallocated Reserve (68.91 - 3492) to Research (62.85 - 3399), and that the expenditure of said funds is hereby authorized, solely and exclusively, for the purpose of providing funds for this purpose.

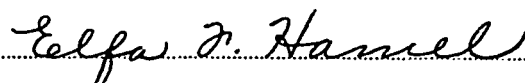

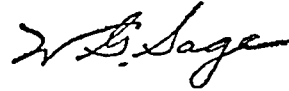

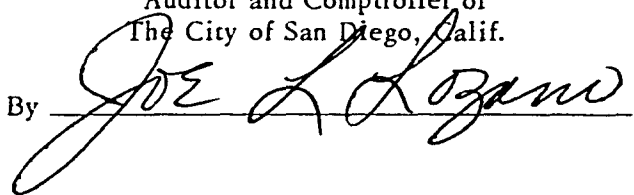

CERTIFICATION OF UNENCUMBERED BALANCE

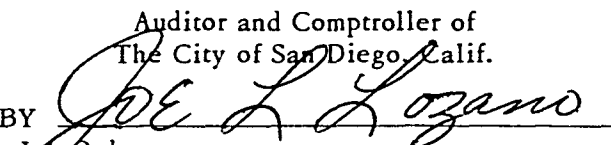
