

WHEREAS, The City of San Diego acquired a certain parcel of land in a portion of the Northeast Quarter of Section 35, Township 18 South, Range 2 West, S.B.M., in the County of San Diego, State of California, according to United States Government Survey, approved February 25, 1870, by deed recorded November 5, 1969 as Document No. 203016, in the office of the San Diego County Recorder, for open space park purposes; and

WHEREAS, the City Manager of said City applied for a federal grant under the Land and Water Conservation Act (P.L. 88-578) for the construction of a swimming pool and partial development of the scheduled park; and

WHEREAS, said federal grant has been approved and the federal government requires that certain restrictions be included in said deed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the deed to The City of San Diego of a portion of the Northeast Quarter of Section 35, Township 18 South, Range 2 West, S.B.M., in the County of San Diego, State of California, according to United States Government Survey, approved February 25, 1870, filed November 5, 1969, as Document No. 203016, in the office of the San Diego County Recorder, be, and it is hereby subject to the following restrictions:

"The land described in said deed, or any interest therein, may not be sold, leased or otherwise transferred by The City of San Diego without prior written approval of the Secretary of Housing and Urban Development, his designee or any successor thereto."

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder of said County of San Diego.
