

RESOLUTION No. 200603


Adopted on AUG 25 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a Lease Agreement with BALBOA TENNIS CLUB, a nonprofit corporation, leasing the kitchen facilities, including hall closet, located in the Morley Field Tennis Center Building in Balboa Park, for a term of one (1) year ending July 31, 1971, at a rental of \$50.00 per month, for the purpose of operating and maintaining the food concession at Morley Field Tennis Center with the exclusive right to sell food, nonalcoholic beverages and sundries, under the terms and conditions set forth in the form of Lease Agreement, on file in the office of the City Clerk as Document No.


