BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Walter Hahn, Jr., City Manager, is authorized to execute and file an application on behalf of San Diego Transit Corporation with the U. S. Department of Transportation to aid in the financing of forty (40) new buses to be used in City transit service.
- 2. That Walter Hahn, Jr., City Manager, is authorized to execute and file with such application an assurance of any other document required by the U. S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964.

Department of Transportation may require in connection with the application of the project.
