

RESOLUTION NO. 200608 AUG 25 1970

A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION WITH THE DEPARTMENT OF TRANSPORTATION, UNITED STATES OF AMERICA, UNDER THE URBAN MASS TRANSPORTATION ACT OF 1964, AS AMENDED.

WHEREAS, the Secretary of Transportation is authorized to make grants for mass transportation projects; and

WHEREAS, the contract for financial assistance will impose certain obligations under the application, including the provision by it of the local share of project costs; and

WHEREAS, it is required by the U. S. Department of Transportation, in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under the Urban Mass Transportation Act of 1964, as Amended, the applicant gives an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U. S. Department of Transportation requirements thereunder; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Walter Hahn, Jr., City Manager, is authorized to execute and file an application on behalf of San Diego Transit Corporation with the U. S. Department of Transportation to aid in the financing of forty (40) new buses to be used in City transit service.

2. That Walter Hahn, Jr., City Manager, is authorized to execute and file with such application an assurance of any other document required by the U. S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964.

3. That Walter Hahn, Jr., City Manager, is authorized to furnish such additional information as the U. S. Department of Transportation may require in connection with the application of the project.
