A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO ELECTING TO PAY OUT OF MUNICIPAL FUNDS ONE HUNDRED PERCENT (100%) OF AN AMOUNT IN LIEU OF TAXES WHICH WOULD OTHERWISE BE LEVIED UPON PROPERTY WITHIN THE CITY BY THE SAN DIEGO COUNTY WATER AUTHORITY FOR THE FISCAL YEAR BEGINNING JULY 1, 1970 AND ENDING JUNE 30, 1971.

WHEREAS, the Board of Directors of the San Diego
County Water Authority (Authority) has levied a tax upon
taxable property within the Authority's jurisdiction for
the fiscal year beginning July 1, 1970 and ending June 30,
1971, for the following purposes:

- 1. Meeting the interest and sinking fund requirements on all outstanding bonded indebtedness of the Authority, including the payment of principal and interest on any outstanding refunding bonds as well as any unissued bonds, which may have been authorized by the electors of the Authority and which in the judgment of the Board of Directors will be issued prior to the time that money to service such bonds would be available from the next subsequent tax levy;
- 2. Meeting the obligations of the Authority to the United States of America and any board, department or agency thereof;
- 3. Meeting special taxes levied upon property in the City pursuant to Section 10 of the County Water Authority Act as prescribed by the terms of the applicable resolution of the Board of Directors fixing conditions for annexation of such area to the Authority;
- 4. All other Authority purposes; and
 WHEREAS, this Council did on the 9th day of December
 1969 adopt Resolution No. 198601 by which the Council
 declared its intention to pay out of municipal funds one

hundred percent (100%) of an amount in lieu of taxes which would otherwise be levied by the Authority upon property within the City for the fiscal year commencing July 1, 1970 and ending June 30, 1971; and

WHEREAS, there is now available or will be available on the date required, in the appropriate fund of The City of San Diego, a sum sufficient to pay one hundred percent (100%) of the in-lieu amount; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The Council hereby elects to pay out of the appropriate fund of the City, the sum of \$1,317,576.66 and hereby appropriates such sum as payment of one hundred percent (100%) of an amount in lieu of taxes which would otherwise be levied upon property within the City by the San Diego County Water Authority for the fiscal year commencing July 1, 1970 and ending June 30, 1971.

Section 2. Payment of the in-lieu amount shall be made on the dates and in the amounts indicated in Section 3 of this resolution for the following purposes:

- (a) The sum of \$1,035,031.88 representing one hundred percent (100%) of the in-lieu amount to be paid for the purpose of meeting the interest and sinking fund requirements on outstanding bonded indebtedness, including payment of the principal and interest on any outstanding refunding bonds as well as any unissued bonds, which may have been authorized by the electors of the Authority and which in the judgment of the Board of Directors will be issued prior to the time that money to service such bonds would be available from the next subsequent tax levy.
- (b) The sum of \$282,544.78 representing one hundred percent (100%) of the in-lieu amount to be paid for the purposes of meeting the obligations of

the Authority to the United States of America and any board, department or agency thereof, and for all other Authority purposes.
