

WHEREAS, The City of San Diego is the owner of a blanket easement for water wells and an easement for sewer purposes in a portion of Pueblo Lot 1120 of the Pueblo Lands of San Diego; and

WHEREAS, the owners of the property have requested that the City release to them all of the City's interest in and to said easements; and

WHEREAS, said easements were acquired for utility purposes and have been determined surplus by the Utilities Director of said City as long as the City reserves the rights in and to the waters of the San Diego River; and

WHEREAS, the Release of Rights will reserve the rights in and to the waters of the San Diego River to City; and

WHEREAS, a fee of \$35.00 has been collected to cover the processing of this request; and

WHEREAS, the release of the aforementioned property rights is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That those certain property rights described in that form of Release of Rights, on file in the office of the City Clerk as Document No. 733169, be, and the same are hereby released to THE OWNERS IN FEE SIMPLE OF RECORD of a portion of Pueblo Lot 1120 of the Pueblo Lands of San Diego.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Release of Rights, the form of which is on file in the office of the

City Clerk as Document No. 733169, releasing and relinquishing to THE OWNERS IN FEE SIMPLE OF RECORD of a portion of Pueblo Lot 1120 of the Pueblo Lands of San Diego, certain rights for water wells, together with an easement for sewer purposes, across a portion of Pueblo Lot 1120 of the Pueblo Lands of San Diego, as more particularly described in said form of Release of Rights.

3. That the City Clerk of said City is hereby authorized and directed to deliver said Release of Rights to the Property Director for further handling.
