

WHEREAS, the Council of The City of San Diego passed Resolution No. 53560 on April 21, 1930 which said resolution dedicated a 100-foot right-of-way for Gilman Drive (formerly U.S. 101); and

WHEREAS, the description contained in said resolution of the land dedicated for the aforesaid right-of-way was erroneous; and

WHEREAS, it is necessary to correct the legal description contained in Resolution No. 53560 to conform with other recorded documents which are affected by said description; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Resolution No. 53560 is hereby amended to substitute the following legal description for that appearing in the second paragraph of said resolution:

Beginning at a City Disc in Concrete Control Monument "Cliff" (coordinates: N=251,551.73, E=1,696,387.37) on the southerly line of said Pueblo Lot 1279; thence along said southerly line, North 76° 24' 40" East (Record: North 75° 56' 08" East), 349.96 feet to the Northeast corner of Pueblo Lot 1290, and North 76° 22' 05" East (Record: North 75° 01' 20" East), 380.79' to the TRUE POINT OF BEGINNING, being also a point on a 3000.00 foot radius curve concave easterly in said center line, a radial line bears South 86° 33' 40" West to said point, thence along said center line northerly along said curve 203.77 feet through an angle of 03° 53' 50", and tangent to said curve North 00° 27' 30" East 665.72 feet (Record: North 00° 51' 28" West 664.86 feet) to a point on the North line of said Pueblo Lot, said point also being 50' easterly from the most southeasterly corner of La Jolla Scenic Heights (Map 4382).
