BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$10,983.00 by L. R. Hubbard DBA Hubbard Const. Co. for the CONSTRUCTION OF "EL CHARRO MEXICANO" MONUMENT BASE IN PRESIDIO PARK in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in the form on file in the office of the City Clerk as Document No. 732922.

2. That the expenditure of \$12,000 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF "EL CHARRO MEXICANO" MONUMENT BASE IN PRESIDIO PARK in the City of San Diego, and related costs.




