RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO
AWARDING A CONTRACT TO IMPROVE AND TO ESTABLISH THE
GRADE IN ALLEY, BLOCK 3, GURWELL HEIGHTS; AND TO
IMPROVE AND TO CHANGE THE GRADE IN ALLEY, BLOCK 91,
POINT LOMA HEIGHTS, AND ALLEY, BLOCK 6, NORTH SHORE
HIGHLANDS.

at the prices named in the bid of said bidder on file in the
office of the City Clerk.

The City Clerk is hereby directed to cause notice of this
award to be published twice in the City Official Newspaper and
to record notice of this award in the office of the County
Recorder as provided in Section 5248 of the Streets and Highways
Code.
