

RESOLUTION No. 200682

Adopted on SEP 1 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of J. BIDDLE, JR. and MONIQUE BIDDLE, husband and wife as joint tenants, as to Parcel 1 herein described; and CHARLES J. BIDDLE, JR. and MONIQUE F. BIDDLE, husband and wife as joint tenants, as to Parcels 2 and 3 herein described, executed in favor of The City of San Diego, bearing date August 10, 1970, conveying to said City an easement and right of way for street purposes through, over and across portions of Lots 17 and 18 in Block 1, and portions of Lots 19 and 20 in Block 4, of Del Mar Terrace, according to Map thereof No. 1527, filed in the office of the County Recorder of San Diego County, February 5, 1913, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the lands therein conveyed as Parcels 1 and 2 are hereby dedicated as and for a public street and the same are hereby named VIA APRILIA, and the land therein conveyed as Parcel 3 is hereby dedicated as and for a public street and the same is hereby named VIA CORTINA.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
