BE IT RESOLVED, by the Council of The City of
San Diego, as follows:

Section 1. The pending proposed Contract for
Grant to Acquire and/or Develop Land for Open-Space
Purposes No. Calif-OSC-430(G) is hereby in all respects
approved.

Section 2. The City Manager of The City of
San Diego is hereby authorized and directed to execute
Contract No. Calif-OSC-430(G) in two (2) counterparts
on behalf of The City of San Diego and the City Clerk
is hereby authorized and directed to impress and attest
the official seal of the Public Body on each such
counterpart and to forward such counterparts to the
Department of Housing and Urban Development, for execution
on behalf of the Government together with such other
documents relative to the approval and execution of such
counterparts as may be required by the Government.

Section 3. This resolution shall take effect
immediately.
