

WHEREAS, on May 9, 1961, the City Council by Resolution No. 165882 adopted the Sign Policy for Mission Bay Park, as set forth in Document No. 623643; and

WHEREAS, by Resolution No. 187177, adopted May 5, 1966, by the City Council, said Sign Policy for Mission Bay Park was amended to allow certain lessees to construct offsite promotional-directional signs, as set forth in Amendment to Mission Bay Sign Policy, Section 3, "Lessees' Signs," on file in the office of the City Clerk as Document No. 699151; and


WHEREAS, said Amendment to Mission Bay Sign Policy expired June 30, 1970; and
