RESOLUTION APPROVING THE ANNEXATION TO THE CITY OF SAN DIEGO OF CERTAIN UNINHABITED TERRITORY IN THE COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, KNOWN AND DESIGNATED AS "GONZALES CANYON ANNEXATION."

WHEREAS, an application for the annexation of certain uninhabited territory to The City of San Diego, known and designated as GONZALES CANYON ANNEXATION has been filed with the Local Agency Formation Commission pursuant to Government Code Section 54791; and


WHEREAS, the executive officer of this Commission has filed a report relative to said proposed annexation, which report has been reviewed and considered by the Commission, and said Commission has found and determined that:

- 1. The application for annexation is signed by all the owners of the land within the territory proposed to be annexed, or is accompanied by proof that all the owners within such territory have given their written consent to such annexation, as provided in Government Code Section 54797.1.
- 2. The Commission approved this annexation without notice and hearing, and also approved and authorized the legislative body of the City to annex this territory without notice and hearing by the legislative body, and without an election, as provided in Government Code Section 54797.1.
- 3. The territory to be annexed, known and designated as GONZALES CANYON ANNEXATION is as described in this resolution.

WHEREAS, all of the provisions of the Government Code of the State of California, with reference to annexation of territory to a municipality, have been complied with, including the provision for the taxation of the property within said territory to pay its proportionate share of any indebtedness or liability of The City of San Diego contracted prior to or existing at the time of the annexation of said territory; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Council of The City of San Diego hereby approves the annexation to The City of San Diego of that certain territory in the County of San Diego, State of California, designated as GONZALES CANYON ANNEXATION and more particularly described as follows:



GOMEALES CANYON ANNEXATION

All that unincorporated territory in the County of San Dicgo, State of California, being portions of Sections 9 and 16, Township 14 South, Range 3 West, San Bernardino Base and Meridian, according to the Government Survey thereof, lying within the following described boundaries:

Beginning at the Northwest corner of the South Half of the Northwest Quarter of said Section 9, being also a point on the boundary of The City Of San Diego, established by Ordinance Number 7987 (New Series), adopted October 7, 1958, by the Council of The City Of San Diego;

- 1. Thence Southerly, along said City Boundary established by Ordinance Number 7987 (New Series), the following courses:
 - a. Southerly along the Westerly line of said Section
 9 to the Southwest corner of said Section
 9 being also the Northwest corner of said Section
 - b. Southerly along the Westerly line of said Section 16 to an intersection with the Northerly right of way of Old Survey Number 57, according to Plats thereof on file in the County Engineer's Office of said County;
- 2. Thence leaving said City Boundary established by Ordinance Number 7987 (New Series) and proceeding easterly along said Northerly right of way of said Old Survey Number 57, to an intersection with a portion of the

boundary of The City of San Diego, established by Ordinance Number
8975 (New Series), adopted March 5, 1964, by the Council of The City
of San Diego, being also an intersection with the East line of the
West half of the West Half of said Section 16;

- 3. Thence Northerly and Easterly along said City Boundary established by Ordinance Number 8975 (New Series) the following courses:
 - a. Northerly along said East line of the West Half of the West Half of Section 16, to the North line of said Section 16, being also the South line of said Section 9;
 - b. Easterly along said South line of Section 9, to the North-South centerline of said Section 9;
 - c. Northerly along said North-South centerline of Section 9, to the East-West centerline of said Section 9;
 - d. Easterly along said East-West centerline of Section

 9, to the West line of the East 24 Acres of the
 Southwest Quarter of the Northeast Quarter of said

 Section 9, as shown on Record of Survey Map Number

 4457, according to Map thereof on file in the
 San Diego County Recorder's Office;

- e. Northerly along said West line of the East 24 Acres of the Southwest Quarter of the Northeast Quarter of said Section 9, to the North line of the South Half of said Northeast Quarter of Section 9;
- 4. Thence leaving said City Boundary established by Ordinance Number 8975 (New Series) and proceeding Westerly along said North line of the South Half of said Northeast Quarter of Section 9, and along the North line of said South Half of the Northwest Quarter of Section 9, to the point of beginning.
