

RESOLUTION NO. 200724 SEP 8 1970

APPROVING MAP OF LA JOLLA SCENIC KNOLLS UNIT  
NO. 3 SUBDIVISION AND ACCEPTING ON BEHALF OF  
THE CITY OF SAN DIEGO THE EASEMENTS GRANTED  
ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by E. F. COOK, Registered Civil Engineer, and entitled, "LA  
JOLLA SCENIC KNOLLS UNIT NO. 3 Being a subdivision of a  
portion of Pueblo Lot 1279 of the Pueblo Lands of San Diego,  
in the City of San Diego, County of San Diego, State of  
California, according to Map thereof made by James Pascoe  
in 1870, a copy of said map was filed in the office of  
County Recorder of San Diego County, November 14, 1921 and  
known as Miscellaneous Map No. 36.", is made in the manner  
and form prescribed by law and conforms to the surrounding  
surveys; that said map and the subdivision of land shown  
thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts  
on behalf of The City of San Diego, a municipal corporation,  
the easements with the right of ingress and egress for the  
construction and maintenance of water and drainage facilities  
as granted and shown on said map and subject to the conditions  
set forth thereon.


The Clerk of said City is hereby authorized and directed
