APPROVING MAP OF LARWIN MESA VIEW UNIT NO. 5 SUBDI-VISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO, THE EASEMENT GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled, "LARWIN MESA VIEW UNIT NO. 5 Being a subdivision of a portion of the South Half of the Southeast Quarter of Section 25, Township 14 South, Range 3 West, San Bernardino Meridian, according to United States Government Survey, approved August 14, 1876, in the City of San Diego, County of San Diego, State of California, excepting all minerals and mineral rights, oil, gas and hydrocarbons together with the right to drill but without the right of surface entry as reserved by Larwin Company, a California corporation, in deed recorded June 16, 1970.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets. to wit: Calle Morelos, Aries Road, Pallux Way, Borealis Road and Hydra Lane for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
