No. 733309, respectively, issued in connection with the contract between The City of San Diego and GRIFFITH COMPANY for the construction of a dual runway and associated improvements at MONTGOMERY FIELD, said contract having been filed as Document No. 729063 in the office of the City Clerk be, and the same are hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$2,760.00 and \$9,168.00 for a total amount of \$11,928.00 be, and the same are hereby approved.

That the request contained in said Change Order Nos. 4-A and 4-B for an extension of time of 200 days and 15 days, respectively, for a total of 215 days, to wit, to and including September 26, 1970, in which to complete said contract be, and the same are hereby approved, and the time of completion under said contract is hereby extended to September 26, 1970.
