That the expenditure of \$3,200 is hereby authorized out of Gas Tax Fund 219 of The City of San Diego, solely and exclusively for the purpose of modification of traffic signals at Balboa Avenue and Clairemont Drive, Garnet Street and Mission Bay Drive, and La Jolla Mesa Drive/Mission Boulevard and Turquoise Street in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for the modification of the above described traffic signals, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
