RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CHANGES IN THE ASSESSMENT AND PLANS.

(Chateau Ville Assessment District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council adopted resolution of intention, Resolution No. 200331, ordering the City Engineer to prepare the Report required by said Act and, pursuant thereto, the City Engineer has prepared said Report, consisting of plans and specifications describing the proposed improvements, an estimate of the costs and expenses of said improvements, a diagram showing the assessment district and a proposed assessment of the costs and expenses of the proposed improvements, said Report being on file with the City Clerk; and

WHEREAS, the Council adopted Resolution No. 200332 approving said Report, as filed, and appointing a time and place of hearing thereon; and

WHEREAS, the Council adopted Resolution No. 200333 inviting bids for the construction of the proposed improvements and also inviting bids for the purchase of bonds to be issued to represent unpaid assessments and, pursuant thereto, bids have been received and opened prior to the time of said hearing; and

WHEREAS, certain property owners have filed written requests with the City Clerk for the deletion or addition of off-street electric and communication facilities serving properties owned by them and the Council desires to amend the plans in accordance therewith; and

WHEREAS, based on the best responsible bids received for the construction of the improvements and for the purchase of the bonds, the actual construction cost and actual bond discount differ from the estimated construction cost and estimated bond discount, as set forth in said Report, and by reason thereof the Council deems it advisable to change the amounts of the total assessment and the individual assessments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The Council hereby orders that the assessment be modified and that the amounts of the individual assessments and the total amount of the assessment be changed in accordance of the "SCHEDULE OF CHANGES" with Exhibit attached hereto and made a part hereof and the Superintendent of Streets is authorized and directed to change the assessment, as filed with the City Clerk, in conformance therewith.

Section 2. The Council hereby orders the plans amended in the "SCHEDULE OF CHANGES" attached hereto and made a part hereof, and the Superintendent of Streets is authorized and directed to make such amendments in the plans.
