Willard S. Paulson	PARKS & PUBLIC BUILDINGS DEPARTMENT Buildings & Facilities Division	\$75	Suggestion was to stock less expensive plywood for work not requiring present stock. Estimated saving is about \$1,500 per year. Actual saving will be checked at end of year.
James C. Fuson Vincent S. Fletcher	PUBLIC WORKS DEPARTMENT Equipment Division	\$20	Air valves in supply lines for air control mirrors on dump trucks are expected to reduce maintenance by about \$200 a year.
James A. Oxe	PUBLIC WORKS DEPARTMENT Equipment Division	\$10	Putting vehicle numbers on the front of City vehicles, as suggested, is expected to save the time of service men looking for specific vehicles listed for service or maintenance. It will take four years to cover all vehicles as they are in the paint shop for other purposes.
