APPROVING MAP OF FAIRMOUNT COMMERCIAL TRACT SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PORTION OF PUBLIC STREET AND THE ALLEY DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENT GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM J. CLARKE, Licensed Land Surveyor, and entitled, "FAIRMOUNT COMMERCIAL TRACT Being a subdivision of Lots 9 through 24 inclusive and Lots 29 through 36 inclusive, together with the vacated alley adjacent thereto, all in Block 46, in the City of San Diego, in the County of San Diego, State of California, according to Map thereof No. 1007, filed in the office of County Recorder of San Diego County, October 3, 1906.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the portion of public street, to wit: a portion of University Avenue and the alley for public purposes and said portion of street and the alley are hereby declared to be portion of a public street and the alley and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer and water facilities as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council,

that said Council has approved said subdivision map and that said portion of street and the alley are hereby accepted on behalf of the public as heretofore stated, and that that certain easement with the right of ingress and egress for the construction and maintenance of sewer and water facilities as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
