APPROVING MAP OF HALECREST VIEW SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS DEDICATED ON SAID MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, a Registered Civil Engineer, and entitled, "HALECREST VIEW Being a subdivision of portions of Lots 2, 3, 4 and 5 in Block 9 of Angelus Heights according to Map thereof No. 1494, filed in the office of the County Recorder of San Diego County November 13, 1912, including a portion of Roscoe Avenue as shown on said Map No. 1494; together with all of Parcel 'A' and portions of Lots 131, 145 and 166 and portions of Marjorie Drive, Viewcrest Drive and Harlan Circle, all being in Halecrest Heights Unit No. 1, according to Map thereof No.4747, filed in the office of the County Recorder of San Diego County, April 19, 1961; all of the above described land being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Viewcrest Drive and Harlan Circle, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.
