STREETS DEDICATED ON SAID MAP WITHIN THIS SUB-
DIVISION.


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by E. F. COOK, a Registered Civil Engineer, and entitled,
"HALECREST VIEW Being a subdivision of portions of Lots 2,
3, 4 and 5 in Block 9 of Angelus Heights according to Map
thereof No. 1494, filed in the office of the County Recorder
of San Diego County November 13, 1912, including a portion
of Roscoe Avenue as shown on said Map No. 1494; together with
all of Parcel 'A' and portions of Lots 131, 145 and 166 and portions
of Marjorie Drive, Viewcrest Drive and Harlan Circle, all being
in Halecrest Heights Unit No. 1, according to Map thereof No. 4747,
filed in the office of the County Recorder of San Diego County,
April 19, 1961; all of the above described land being in the
City of San Diego, County of San Diego, State of California.",
is made in the manner and form prescribed by law and conforms
to the surrounding surveys; that said map and the subdivision
of land shown thereon is hereby approved and accepted; and
said Council hereby accepts on behalf of the public, the public
streets, to wit: Viewcrest Drive and Harlan Circle, for public
purposes, and said streets are hereby declared to be public
streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that
said Council has approved said subdivision map and that said public
streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map
to the Clerk of the Board of Supervisors of the County of San
Diego, California.
