BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "PLAZA DE SAN YSIDRO UNIT NO. 2 Being a subdivision of portions of Lot 1 of Vagabond Trailer Court per Map No. 4781, a portion of Lot A-292 of Addition No. 7 in San Ysidro as per Map 1500, a portion of the Northeast Quarter of the Northeast Quarter of Section 2, Township 19 South, Range 2 West, and a portion of the Southeast Quarter of the Southeast Quarter of Section 35, Township 18 South, Range 2 West, San Bernardino Meridian, together with a portion of San Ysidro Boulevard, as shown on Plaza de San Ysidro Unit No. 1, Map No. 6592, filed in the office of the County Recorder of San Diego County February 24, 1970, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portion of public street, to wit: portion of San Ysidro Boulevard for public purposes and said portion of street is hereby declared to be portion of public street and dedicated to the public use.
