APPROVING MAP OF SAN DIEGO CENTER UNIT NO. 1
SUBDIVISION AND ACCEPTING ON BEHALF OF THE
PUBLIC THE PORTION OF PUBLIC STREET DEDICATED
ON SAID MAP, AND ACCEPTING ON BEHALF OF THE
CITY OF SAN DIEGO THE EASEMENTS GRANTED ON
THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by WILLIAM B. RICK, Registered Civil Engineer, and entitled,
"SAN DIEGO CENTER UNIT NO. 1 Being a subdivision of a por-
tion of the Southwest Quarter of Section 1, Township 14 South,
Range 4 West, San Bernardino Meridian, in the City of San Diego,
County of San Diego, State of California, according to the
official Plat thereof; excepting therefrom any portion thereof
now or heretofore lying below the ordinary high tide line of
the Pacific Ocean, or any so-called arm of the sea.", is made
in the manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public, portion of public
street, to wit: a portion of Via de la Valle for public purposes
and said portion of street is hereby declared to be portion of
public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation, the
easements with the right of ingress and egress for the construction
and maintenance of drainage facilities as granted and shown on
this map within this subdivision.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and that the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
