BE IT RESOLVED, by the Council of The City of San Diego,
California, that ALLEY, BLOCK 46, CITY HEIGHTS, ADJACENT TO
LOTS 13 THROUGH 36,

as more particularly referred to in Resolution of Intention
No. 200620 is unnecessary for present or prospective
public street purposes.

BE IT FURTHER RESOLVED, that the public interest, con-
venience and necessity of said City requires the reservation
of certain public easement(s), as more particularly referred
to in Resolution of Intention No. 200620.

BE IT FURTHER RESOLVED, that ALLEY, BLOCK 46, CITY
HEIGHTS, ADJACENT TO LOTS 13 THROUGH 36,

as more particularly shown on Map No. 12320-B on file
in the office of the City Clerk as Document No. 733140,
which said map is attached hereto marked Exhibit A and made a
part hereof, be, and the same is hereby vacated.

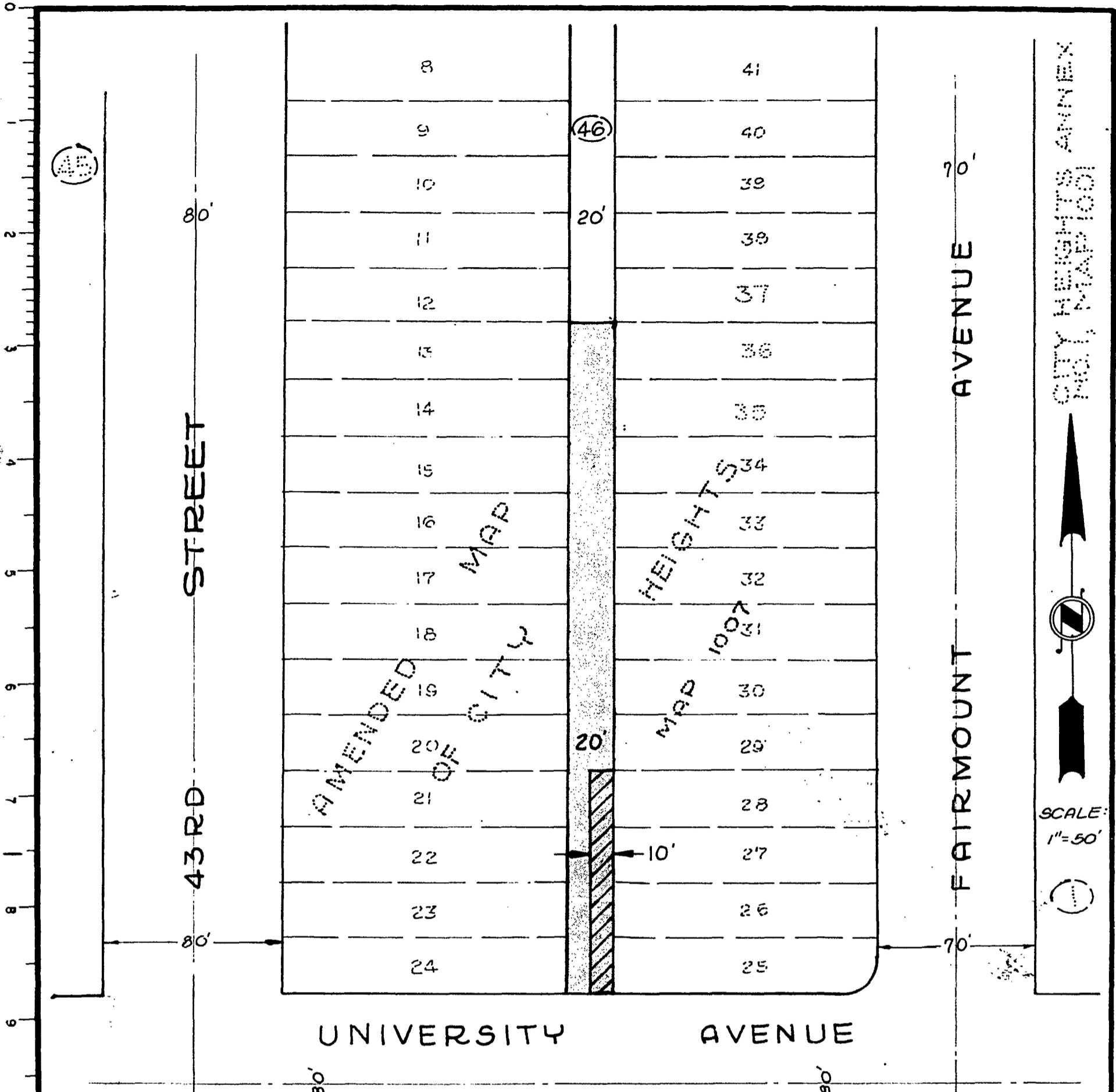
BE IT FURTHER RESOLVED, that The City of San Diego reserves
and excepts from the foregoing vacation the permanent easement(s)
as more particularly shown on Map No. 12320-B, on file in
the office of the City Clerk as Document No. 733140, and
as more particularly described hereinafter:

Reserving and excepting to The City of San Diego the right, easement and privilege of placing, constructing, repairing, replacing, maintaining, using and operating sewer and water facilities and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easement, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon written permission of the City or any grantee from the City of the right to utilize the said easement herein, the owners of the underlying fee may utilize the above described parcel of land for structures, the planting or growing of trees or the installation of privately owned pipelines.

The easement reserved herein is in, under, over, upon, along and across the following described property:

The easterly ten feet of said
ALLEY, ADJACENT TO LOTS 25
THROUGH 28, BLOCK 46, CITY HEIGHTS.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, including the attached Exhibit A, attested by him under seal, to be recorded in the office of the County Recorder.
