

WHEREAS, pursuant to Resolution No. 199517, adopted April 19, 1970, a public auction was held on August 21, 1970, at 10:00 a.m., for the purpose of selling Lots 5 and 6, Block 1, Clifton Addition to City Heights, according to Map thereof No. 1337, filed May 25, 1911, in the office of the San Diego County Recorder; and

That the bid of Stephen Del Mundo for said property be, and the same is hereby declared the highest bid received for the sale of said property, and said bid is hereby accepted on all those terms and conditions set forth in said Resolution No. 199517, and upon said terms and conditions said property is hereby sold to Stephen Del Mundo and Lynn Ena Del Mundo, husband and wife, as joint tenants, at the price bid at said public auction sale, to wit: Nine Thousand Seven Hundred Dollars (\$9,700.00).

2. That the Mayor and the City Clerk of The City of San Diego be, and they are hereby authorized and empowered to execute, for and on behalf of and as the act and deed of The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No.


