That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO, a political subdivision of the State of California, pertaining to an Offshore Airport Study in the City of San Diego, under the terms and conditions as set forth in the form of agreement on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$38,300.00 from the General Fund 100 Unallocated Reserve 53.30 to Department 43.16 100 FD, Offshore Airport Study, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the City's share of these study costs in connection with the project described above.
