

RESOLUTION No. 200837

Adopted on SEP 22 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Offer to Dedicate of KARL A. SACK and MARY E. SACK, executed in favor of The City of San Diego, bearing date May 24, 1970, granting to said City an offer to dedicate to public use for future street purposes that land described as a portion of Pueblo Lot 143 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in the year 1870, a copy of which said Map was filed in the office of the County Recorder of said San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 36, be, and the same is hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance the City does not dedicate to public use for street purposes the portion of land described in said instrument but reserves the right to so dedicate at a future time.

AND BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to transmit the foregoing said offer to dedicate to the Property Department for recording and further disposition.
