

RESOLUTION NO. 200849 SEP 24 1970

APPROVING MAP OF LARWIN MESA VIEW UNIT NO. 6 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND PORTION OF PUBLIC STREET DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE ABUTTERS' RIGHTS OF ACCESS, TOGETHER WITH THE EASEMENT AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled, "LARWIN MESA VIEW UNIT NO. 6 Being a subdivision of a portion of the South Half of the Southeast Quarter of Section 25, Township 14 South, Range 3 West, San Bernardino Meridian, according to United States Government Survey, approved August 14, 1876, in the City of San Diego, County of San Diego, State of California; excepting all minerals and mineral rights, oil, gas and hydrocarbons together with the right to drill but without the right of surface entry as reserved by Larwin Company, a California corporation, in deed recorded June 16, 1970.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets and portion of public street, to wit: Calle Morelos, Aries Road, Borealis Road, Crater Place, Columba Place, Hydra Lane, Pallux Way, Virgo Place and a portion of Camino Ruiz for public purposes; and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Camino Ruiz, adjacent and contiguous to Lots 523, 616, 606, 605, 604, 603, 602, 601, 600, 599, 598, 597, 596, 595, 587 and 586, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
