

# RESOLUTION No. 200856

Adopted on SEP 24 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LEWIS H. DOWDY and ADALINE H. DOWDY, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date September 24, 1969, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 4, Block 341 of Old San Diego according to Map thereof made by James Pascoe in 1870, on file in the Office of the City Engineer of the City of San Diego, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named HANCOCK STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the Office of the Recorder of San Diego County.
