WHEREAS, the Planning Commission of The City of San Diego has held a public hearing to consider the proposed Clairemont-Mesa Community Plan, prepared by the Planning and Community Development Departments in cooperation with the citizens of the Clairemont-Mesa area of the City; and

WHEREAS, the Clairemont-Mesa Community Plan will serve as a guide for the development of an area comprising approximately 9385 acres of land bounded generally on the north by San Clemente Canyon, on the east by Interstate 805 and Route 163, on the south by Tecolote Canyon, and on the west by Interstate 5; and

WHEREAS, on August 12, 1970, the Planning Commission adopted and recommended for approval to the City Council the Clairemont-Mesa Community Plan; and


WHEREAS, the Council of The City of San Diego has held a public hearing to consider this plan; NOW, THEREFORE,
