

# RESOLUTION No. 200862

Adopted on SEP 29 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Geo F. Kennedy, Inc. 2. General Tire Service 3. Brownie's Tire Co. and 4. Goodyear Service Stores, A Division of the Goodyear Tire & Rubber Company are hereby accepted; and the City Manager is hereby authorized to execute contracts for the purchase of TIRES AND TUBES for the year commencing August 1, 1970 through July 31, 1971 as follows:

1. Geo F. Kennedy, Inc. for Group I (passenger car tires) at 25% off Net State Price List; terms 2% 10th prox., plus sales tax, and;

2. General Tire Service for Group II (light truck tires) at 10-10-10% off Net State Price List; terms net 10th prox., plus sales tax, and;

3. Brownie's Tire Co. for Group III (heavy truck and bus tires) and Group V (heavy duty passenger tubes) at 25% off Net State Price List; terms net 30 days, plus sales tax, with option for additional year, and;

4. Goodyear Service Stores, A Division of the Goodyear Tire & Rubber Company for Group IV (off-the-road truck tires, grader, tractor and farm tires) and Group VI (heavy duty truck, grader, tractor and farm tubes) at 25% off Net State Price List; terms net 30 days, plus sales tax, with option for additional year.
