THAT A FINDING BE, AND IT IS HEREBY MADE, That a testing facility and firing range, proposed to be located in the M-1A zone on Portion of Sections 20 and 21, Township 14 South, Range 1 West, S.B.B.M. located in Sycamore Canyon approximately 6 miles east of U.S. Highway 395, by General Dynamics, is an enterprise similar to and not more obnoxious or detrimental to the welfare of the particular community than those enterprises or businesses permitted in Section 101.0436, San Diego Municipal Code.
