That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an option agreement with the Omega Housing and Development Company for approximately 30 acres of City-owned property located north of Market Street and east of Boundary Street, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 733506.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a lease agreement with the Omega Housing and Development Company upon fulfillment to his satisfaction of the conditions specified in the option agreement, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document NO. 733526.
