RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AWARDING A CONTRACT TO IMPROVE AND TO ESTABLISH THE GRADE IN ALLEY, BLOCK 2, LOMA VIEW, AND ALLEY, BLOCK 3, SILVER TERRACE; AND TO IMPROVE AND TO CHANGE THE GRADE IN ALLEY, BLOCK C, RIVIERA VILLAS.

WHEREAS, the Purchasing Agent of The City of San Diego, California, as authorized by City Council Resolution No. 183404, did on September 9, 1970 publicly open, examine and declare all sealed proposals or bids for doing the work and improvement described in Resolution of Intention No. 200088, which Resolution of Intention is hereby expressly referred to for description of said work and improvement, and for all particulars relative to the proceedings under said Resolution of Intention; NOW, THEREFORE,

That the Council of The City of San Diego, California, hereby rejects all said proposals or bids except that herein mentioned and hereby awards the contract for doing said work and improvement to the lowest regular responsible bidder to wit: T. B. PENICK & SONS, INC.

at the prices named in the bid of said bidder on file in the office of the City Clerk.

The City Clerk is hereby directed to cause notice of this award to be published twice in the City Official Newspaper and to record notice of this award in the office of the County Recorder as provided in Section 5248 of the Streets and Highways Code.
