

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to San Carlos Drive, over and across a portion of Lot 33, San Carlos Unit No. 4, according to Map thereof No. 4298, filed in the office of the San Diego County Recorder, said portion of said Lot 33 now being known as Parcel "A" of Parcel Map No. 240, filed April 28, 1970, in the office of the San Diego County Recorder; and

WHEREAS, the owners of the property have requested that the City revest these abutter's rights of access in the property to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights of access; and

WHEREAS, the City should now authorize the execution of the necessary quitclaim deed to effect the revestment of said access rights; and

WHEREAS, a fee of \$35.00 has been collected to cover the processing of this request; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

to THE OWNERS IN FEE SIMPLE OF RECORD of Lot 33, San Carlos Unit No. 4, now known as Parcel "A" of Parcel Map No. 240, effecting the revestment of those abutter's rights of access to San Carlos Drive of said Lot 33, San Carlos Unit No. 4, now known as Parcel "A" of Parcel Map No. 240, heretofore relinquished to the City, more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
