

RESOLUTION No. 200887

Adopted on SEP 29 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PRESIDENT JOHN ADAMS MANOR, a California corporation, executed in favor of The City of San Diego, bearing date June 30, 1970, conveying to said City an easement and right of way for street purposes through, over and across portions of Lots 11, 12 and 13 of Bayview Heights Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5289, filed in the County Recorder's office October 30, 1963, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named BAYVIEW HEIGHTS PLACE.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
