

RESOLUTION NO. 200902 OCT 1 1970

APPROVING MAP OF CASA DE ALCALA SUBDIVISION AND
ACCEPTING ON BEHALF OF THE PUBLIC PORTION OF
PUBLIC STREET DEDICATED ON SAID MAP WITHIN THIS
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by DON NASLAND, Licensed Land Surveyor, and entitled, "CASA DE
ALCALA Being a subdivision of a portion of Lot 48 of Rancho
Mission of San Diego, in the City of San Diego, County of San
Diego, State of California, according to partition map thereof
made in the action entitled 'Juan M. Luco, et al, vs. the
Commercial Bank of San Diego, et al.,' under Superior Court
Case No. 348 on file in the Office of the County Clerk of
San Diego County.", is made in the manner and form prescribed
by law and conforms to the surrounding surveys; that said map
and the subdivision of land shown thereon is hereby approved and
accepted; and said Council hereby accepts on behalf of the
public, portion of a public street, to wit: portion of Rancho
Mission Road, for public purposes, and said portion of street
is hereby declared to be portion of public street and dedicated
to the public use.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that
said Council has approved said subdivision map and that said
portion of public street is accepted on behalf of the public as
heretofore stated.

Said City Clerk is hereby directed to transmit said map to
the Clerk of the Board of Supervisors of the County of San Diego,
California.
