Diego, as follows:


Said Council hereby finds that that certain map surveyed

entitled "ENCANTO PLAZA HEIGHTS UNIT NO. 1 Being a sub-
division of a portion of Lot 1, Encanto Plaza Annex, in
the City of San Diego, County of San Diego, State of California,
according to Map thereof No. 5229, filed in the office of
the County Recorder of San Diego County, August 7, 1963
together with a portion of that certain lot designated as
'Hoffman' on the Map of Encanto, in said City and State,
according to Map thereof No. 749, filed in the office of
said County Recorder, May 6, 1895.", is made in the manner
and form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown
thereon is hereby approved and accepted.

to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map.
