

WHEREAS, heretofore by deed recorded November 24, 1959, in Book 8010 at Page 72 of Official Records of the San Diego County Recorder, The City of San Diego acquired an easement for drainage purposes affecting a portion of Lot 6, Block 55, Linda Vista Unit No. 4; and

WHEREAS, said easement has never been used for the purpose for which it was acquired and more than one (1) year has elapsed since the date said easement was acquired; and

WHEREAS, said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the drainage easement more particularly described hereinafter is hereby vacated:

That certain easement for drainage purposes affecting a portion of Lot 6, Block 55, Linda Vista Unit No. 4, according to Map thereof No. 3256, filed June 24, 1955, in the office of the San Diego County Recorder, being a strip of land 10.00 feet in width described in deed to The City of San Diego, executed by Roy A. Cook and Virginia R. Cook, dated November 3, 1959, and recorded November 24, 1959, in Book 8010 at Page 72 of Official Records of San Diego County.


That from and after the date of this order of vacation, title to the land previously subject to said drainage easement shall revert to the owner of the land free from the rights of the public.
